




Motivation

- SABI is widely used for business research
 - It is the local version of the ORBIS database
- BORME, the official business registry, provides a complementary source.
- Aim: Compare BORME and SABI to identify missing companies.










Research objectives

- Assess how many companies established 2010–2023 are missing in SABI
- Examine coverage by year of establishment, dissolution, province, sector, and legal form
- Uncover potential biases
 - (e.g., survivorship bias, size bias)






Data Sources


- SABI (Bureau van Dijk)
 - Commercial database with financial and registration data
 - Contains around 1.9 million Spanish companies (as of January 2024)




Methodology



- Downloaded and parsed ~100k PDF publications from BORME
- Extracted ~9.96 million entries on 3.05 million firms
- Entries were divided in fields (establishment, dissolution, legal form...)
- Filtered for companies established 2010–2023
 - 1.30 million firms
- Matched with SABI records to identify missing entities










Only 38.3% of firms created 2010–2023 found in SABI









Coverage by Year of Establishment

- Marked underrepresentation of young firms
- ~50% coverage starts around age 5
- Implication: SABI underestimates recent entries



Survivorship Bias


- Dissolved firms gradually disappear from SABI
- Coverage drops around 3.7 pp per year after dissolution
- Results can overestimate the longevity and success rates of the firms






Geographic variation


- Coverage ranges from ~65% (Lugo) to ~18% (Guadalajara)
- No clear link between coverage and population or coastal proximity




Sectoral variation



• Some industries better covered (e.g., Manufacturing), others underrepresented (e.g., Electricity supply)






Legal form variation

- Legal forms with higher capitalization (SA similar to PLC) have better coverage
- SL forms (similar to LLC) are underrepresented

Conclusion




- SABI, like ORBIS, also has coverage limitations.
- It includes well-known companies, but many newer and lesserknown companies are not registered here. Additionally, it may exclude companies dissolved long ago, thus presenting various biases.
- It is necessary to correct these biases, including geographic, sectoral, survival, or selection biases, when preparing a research sample.




Limitations



- Time focus: 2010–2023 (does not capture longer-term trends)
- Companies may fail to deposit statements in the registry
- SABI's own data collection and removal policies are not fully transparent







Conclusion

- SABI covers a limited share of the Spanish corporate landscape, especially recent or small firms
- Survivorship bias and other coverage gaps can affect research results
- Researchers should exercise caution and consider alternative data or methodological corrections
